#### WTC Q & A

Some have asked great questions about what we are supposed to do during the work to the contract. For example, do we still have to do open house? Answer: Yes. Open house is part of our contract requirements. But it is likely your room may not be fully ready because you are not staying after the following Monday, August 20. school to work for free. This is allowed

What about ERPLs, do we have to attend those? Answer: Yes, that too is part of the contract. Remember that is the faculty meeting that week and is the only contractually allowed meeting **Headquarters** after school.

## What about meetings during lunch?

Answer: No, meetings during lunch cannot be required, even for new teachers. Do not attend.

What about trainings for which we are paid \$15 or \$25 per hour? Answer: No. Unless you are paid your hourly rate, you should not attend. I know we all need some extra money, so this one is harder. If we truly want to make an impact, not attending trainings or meetings in which we are paid sometimes as little as half our hourly rate will go a long way.
